<p>The following are mandatory guidelines to be followed when on-site. These have been established for your protection. Failure to comply may result in removal from the site.</p> <p>1. Personal Protection</p> <ul style="list-style-type: none">• At the very least, hard hats, safety glasses with side shields, safety vests, and safety toed boots should be worn at all times, when on GCC property.• Hearing protection will be worn in designated areas.• Appropriate fall protection will be worn when a fall hazard exists.• Tunnels, conveyers, plant structures, stockpiles, high walls, storage tanks, and electrical components are strictly off limits when not accompanied by plant personnel; these may present unfamiliar and extremely dangerous hazards to you.• Eat and smoke only in designated areas.• Take note of first aid stations and fire extinguishers on the map. <p>2. Trucks/Equipment</p> <ul style="list-style-type: none">• All plant mobile equipment has the right of way.• Eye contact will be made with any and all Granite operated equipment before entering their work area. Signal your intentions after eye contact is made and verify operator understood your signal.• Drivers and passengers will remain in their vehicle unless authorized by a plant official. Drivers will stay in their vehicle while being loaded. You will not be loaded if you are not in your truck.• Prior to moving mobile equipment or vehicles the driver must first sound the horn.• Parked, unattended vehicles will have parking break set, and when on a grade, are required to use chock blocks or turn wheels into a bank.• Obey all posted warning, traffic, and speed limit signs.• Use of cell phones are prohibited (Unless with a hands free system).• Use 3 points of contact when mounting/dismounting steps and ladders. <p>3. Contractors</p> <ul style="list-style-type: none">• Contractor equipment must be in safe working condition before entering the site. <p>4. Hazard Recognition/Other</p> <ul style="list-style-type: none">• Do not touch moving machinery. Cross conveyor belts only at designated crossing points. Do not climb over or under conveyers.• Never be under a suspended load.• Blasting occurs quite frequently. Be alert and know the warning signals that tell you when a blast is about to occur.• All aspects of your job must be discussed with the plant supervisor.• Proper task training must be given before any job is done.• Always be on the lookout for rattle snakes, and if you see one report it to the plant supervisor.• Be aware of heat illness, drink plenty of water.• No alcohol, illegal drugs or firearms are allowed of GCC property.• Follow fire watch procedures. <p>Name: _____ Date: _____ Signature: _____ Company: _____</p>

Site Regulations

- All persons on-site are required to follow Granite Policy, OSHA and MSHA regulations. Any questions you may have regarding any of these policies will be addressed by the plant supervisor.

Personal Protection

- To ensure your safety and the safety of others on site, please follow these rules.
- All Heavy Equipment on site has the right of way.
- Climbing on vehicles or trailers is prohibited.
- Stay in vehicle at all times. If exiting your vehicles at any time, minimum PPE required is **HARD HAT, SAFETY TOED BOOTS, SAFETY VEST.**
- Use radio **channel 5** to communicate with operators.

Vehicle Operation


- First check in at scale house.
- Speed limits are Max 15 MPH in the plant or on dirt roads and Max 25 MPH on the haul road.
- Use of Cell Phones are prohibited while operating vehicles.
- Prior to moving vehicles - **sound the horn and have headlights on.**
- Parked unattended vehicles will have parking brake set and tires chalked or turned into a bank.
- Bobtails need to back up to stockpile.
- The Vehicle Driver is responsible for knowing vehicle GVW and communicating it with the weigh master.
- It is the Drivers responsibility to not leave the plant overloaded under any circumstances.
- No left turns for through traffic over 39 in length on 175 and that all traffic laws on 175 must be followed.
